If you do not receive a student ID number, please contact the International Student Program at arcintlprogram@arc.losrios.edu. **STEP 2: INTERNATIONAL STUDENT REQUIRED DOCUMENTS** SEVIS Enrollment Form (pg. 4): Review this form carefully. This form must be typed and completely filled out. Affidavit of Financial Support (pg. 5): Read this section carefully. You and your financial sponsor must complete this form. This is a legal document and should be treated as such. The current bank letter (within the last 3 months) can be from a bank in your country. **SELF-SPONSORSHIP** If you are paying for your tuition as well as living expenses, you must complete the Affidavit of Support and submit a current official bank letter (issued within 3 months of the application deadline) for \$42,239 USD. **FINANCIAL SPONSOR** If you have a financial sponsor (parent, relatives, and government sponsorship) who is paying for your tuition as well as living expenses, you must submit the Affidavit of Support and an official bank letter (issued within 3 months of the application deadline) from your financial sponsor for \$42,239 USD. Official Bank Letter: Must be in English. The bank letter (issued within 3 months of the application deadline) must be from a personal checking/savings account with liquid funds. No business accounts are accepted. No screenshots, transaction histories, etc. are accepted. Additional \$6,000 USD is required for each dependent (spouse/children). AFTER ADMISSION

NEW STUDENTS- I-901 FEE

If you are admitted to ARC as an international student, you will receive your Form I-20 and welcome packet. Before you schedule your visa appointment with the U.S. Embassy, you must pay the I-901 fee and print confirmation receipt by going to fmjfee.com.

FOR CURRENT F-1 TRANSFERS

If you are admitted to ARC as an F-1 transfer student, an admission letter and transfer form will be emailed to you. Take the admission letter and transfer form to your international student advisor for completion.

ARC does not accept pending reinstatement, terminated or completed SEVIS records.

IMPORTANT INFORMATION FOR INTERNATIONAL STUDENTS:

- Must be enrolled in and complete a minumum of 12 units for each Fall and Spring semester at ARC.
- Must maintain a minimum of 2.0 GPA at all times.
- F-1 VISA students have strict employment guidelines. It is prohibited to work in the U.S under an F-1 VISA, except under certain conditions.
- Maintain a valid medical insurance during your attendance at the college.
- Report any changes in contact information within 10 days of the change.
- American River College does not offer on-campus housing; it is the responsibility of the student to find housing accommodations.
- All international students must comply with federal regulations to maintain their F-1 status.
- Students must attend the Mandatory New International Student Orientation.
- Students must report to the office for required check-in before orientation.

Additional requirements: Prior to the first day of classes, students will be required to show proof of health insurance and negative TB testing results.
